6. Business arising from the Minutes:

- Don Lay (project manager/co-ordinator) met with Peter Moroz and Fred Schrader
- Waiting to hear from mechanical/electrical engineer
- Building committee met last night with Fr. Ivan and Marusia
- Looked at various options for office spaces came up with some different plans than from the original plan
- Offices may be located in the basement the old chapel will be wheel chair accessible
- Will need main floor washroom
- Instead of putting the stairs on the outside of the Church possibly put a door from the balcony on the north side of the building to access the 2nd level
- The chapel/vesting room would be nice to leave this as a museum
- The wood work in our building is unique
- Reach out to the museum to see if they have any interest in the bread maker

- New windows and doors will need to be installed – secure windows will need to be installed as this will be ground level – will need security cameras

- The balcony shares a common wall this will save the need to build a staircase
- The Golden Agers room will remain as this will be a multi purpose room (new boardroom)
- Small meeting room in the Chapel and storage room

7. Correspondence:

- Received grant papers (FRP Foundation) which will be sent to Rose Maleschuk to complete. We will require a quote from the architect – we are eligible to receive \$27,000. We can make continue to apply for this grant as long as we have projects on the go.

- We will need to obtain information regarding the transfer of the titles. Transfer of title is always based on our cost – the hall, until now, has never reported to our financial statement – never filed with the CRA – unsure if they're required. If we get the title transferred by Jan. 2/22 – that the hall will start providing us updates as we will have to role their financial report into our financial report. Fred will have to ask some realtors to give him a value of the hall so that Marusia knows what value to transfer.

- Discussion was held regarding subdivision of the Redeemer's Press – subdivide it from the Church in the event we have an interested party who would like to purchase it. It's easier to sell if it's already subdivided from the Church. Marusia's thoughts are that we should have 2 separate lots – 1 for the Redeemer's Voice building and then for the empty parking lot where the monastery will be removed from. The Church will be one piece of property and the Cultural Centre will be another.

- Council will have to meet with the hall committee to let know that as party of the role over this will be happening. The hall will be under the Parish's control which is basically Fr. and Parish Council.

- Eparchy has requested from feedback from Fr. and Fred regarding the appeal.

8. Treasurer's Report - Dolores Harris

- The financials that are attached show that from Jan – Sept. we have a net income of \$6,000 less the \$10,000 CEBA that we have to pay back so we are sitting at a negative \$4,000.

- Some substantial expenses that went through – property taxes and insurance.
