6. Business arising from the Minutes:

a. Sound system - Ron Wizniak fixed it. Father will now try and use the lapel microphone now

• Hazardous Material Sampling Inspection needs to be completed – quote \$17,585. 1080 was surprised by the quote – testing was mainly for asbestos, lead and mercury

Written report submitted by Doreen Rathgeber

• We still have 5 pews left for sale.

• We have another auction coming up for the Redemptorists this week – everything needs to be gone by March 31/22.

Power will be shut off Apr. 1/22. One electrical panel needs to be moved to the church side before this can happen.

• The boilers need to be drained and removed before Sask Energy can shut the gas off only on the monastery side. The hook up for heat in the Sacristy and two upper floors need to be done as soon as it's feasible.

• The city water on the monastery side is an issue as the church is partially connected to it ?? the orders are to disconnect the water on April 1/22.

• The handicap bathroom needs to move to a new location. Plans for the bathroom and permits are needed before this can proceed. A hand washing sink is required in the sacristy. Plumbing and water connections to this sink are an issue. Miller's Plumbing has a plan to set this up.

• There are miscellaneous items parish council needs to ensure they are removed: all work tools in the Bishop's suite, moving cart, wheelchairs and walkers: Robert and the boxed dalmatics, etc in the sacristy (parish council).

• Electric chimes on the second floor will be in the sale.

• Telephones are disconnected from the monastery and the telephone system is set up in the church offices. The security system is almost complete in the church through a digital planning. Teresa is waiting for an estimate of the cost for this installation. Teresa will inform us when she receives this information.

• All exterior doors and windows on the monastery side will be sold. This building needs to be secured before the demolition. The Redemptorists are responsible for this task. Interior doors between the church and monastery will need to be boarded up prior to demolition and if all possible by the end of the auction.

• Miller's Plumbing and Heating will be in to reroute lines – All-Stat Electric will be in to do the electrical work.

• Doreen will let Fr. Michael and Robert Sliva know not to sell the emergency lights and hand sanitizer units

• We paid for the new windows that are in the Church for a cost of about \$40,000. We need to ask Fr. Michael what are his plans for the windows that the parish paid for.

• The bell with the rope which is located on the side of the church should stay. This will addressed during demolition.

• Do we have any drawing with respect to the disconnecting of the wall? NL Construction would like to see how they are planning this. They also need to know about any hazardous materials.

• Redeemer's Voice – there is currently no insurance on the building. It should be insured – at least minimal insurance should be placed on this building as we can be using this for storage and then it won't be labelled as vacant.

• Garage - unsure if this is also insured - again - at least a minimal insurance should be placed on it

• Come spring things are going to start getting busy.

• Invoices over \$5,000 need the Eparchy's approval. Fr. Ivan prepared a letter and we are approved for full cost of up to \$400,000 therefore we won't have to bother the Eparchy with every invoice but will always provide and invoice and update Fr. Ivan on what's happening.

• The invoice for \$17,585 – Hazardous Material Sampling – the parish will be responsible for this. Fred will email Fr. Michael and ask if they will pay for it or help with partial payment.
